CBA Scholarship

The purpose of the Association's fund is to award scholarships to Chelmsford residents who upon graduation from the Chelmsford High School, Nashoba Valley Technical High School or any other accredited private high school, intend to pursue a degree at an accredited two or four year college or junior college.

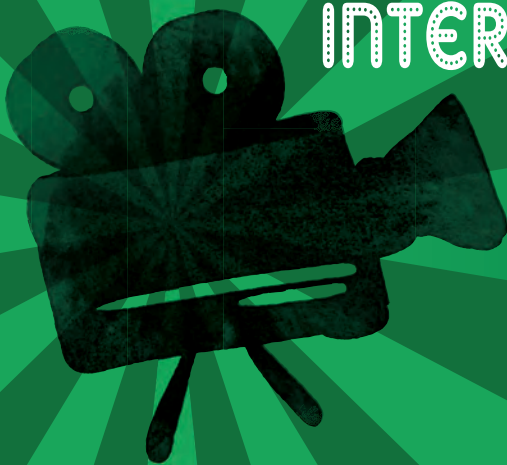
This year a \$1,500 Scholarship is available to any qualifying Chelmsford Student.

To qualify the applicant must be a Chelmsford resident, attend and graduate in the year of this application from Chelmsford High School, Nashoba Valley Technical High School or any other accredited private high school. The applicant must have been accepted to a 2 or 4 year degree granting accredited college or junior college attending on a full-time basis. The applicant must also have a 3.0 cumulative average.

When applying please include a completed application form, a copy of the applicants high school transcript, a copy of post secondary school acceptance letter (if available), and two letters of character reference from a non-family adult.

A completed application must be delivered to the Greater Lowell Community Foundation no later than 5 pm on April 21.

Claim Your SHOP CHELMSFORD “micro” website NOW

It's Fast and Simple:

1. go to www.shopchelmsford.org
2. Under **“For Business Owners”** click **“Claim my Business”**
3. Type your business name in the **“Enter Business Name”** text box.

(a) If your business is already listed in the system database you will be prompted to login or to **“Create Account”** using your email and password and accept “Terms and Conditions” for use of the site. You will receive an email confirmation that you have successfully “claimed” your business. (All first time users will receive an email confirmation “welcoming” you to Shop Chelmsford).

(b) If your business is NOT already listed in the system database you will see **“Is your business not listed below? Register Here”** (in purple text below) the “Enter Business Name” text box. Click **“Register here”**. The next screen will bring you back to step (a) (see above).

**** NOTE: Prior to moving onto next steps in the process all business registrations require administrative approval. You will receive an email confirmation.

4. You are now able to create / manage your micro website. Under **“For Business Owners”** click **“Edit your Business”** and then click **“View My Business Listing”**
5. This screen will allow you to complete all sections that apply to your business. Make certain to click **“SAVE”**. If you need assistance with **“How To’s”** click **“Video”** or **“Support”**.
6. Keep your mirco-website up to date by logging in routinely to post updates, news and new promotions / coupons.


